**BOARD OF STUDIES IN ZOOLOGY FOR THE YEAR 2021-22**

**Resolutions:**

The members present discussed the syllabus relating to I, II III, IV, V & IV semesters including Practical in Zoology and proposed the following resolutions

**Resolution 1:** Resolved to approve the syllabus for I, II III, IV, V & IV semesters for the year 2021 - 2022 as appended herewith.

**Resolution 2 :** Resolved to approve the scheme of examinations for the Six semesters and practical of I B.Sc., II B.Sc., and III B. Sc., Zoology as detailed below:.

- a) The syllabus of each paper is divided in to two semesters (I & II for I Year and III & IV for II Year, V, VI for V semester and one out of three elective paper (VIIA, VIIB, VIIC) will be selected as per the choice of the student, one set of cluster out of three sets (VIIIA-1, A-2, A-3, VIIB-1, B-2, B-3 VIIC-1, C-2, C-3) will be selected as per the choice of the student for III Year. The elective paper selected for this year is **VII B Cellular metabolism** and molecular biology and VIIB Cluster paper is **Aquaculture**
- b) I,II ,III&IV Semester paper of 100 marks each has 30 marks of internal evaluation and 70 marks of External evaluation. The Internal evaluation (30 marks) is distributed as follows: Attendance-5 marks, Assignments-10 marks, internal examination-15 marks
- c) During each semester 2 Internal Examinations for each paper will be conducted as per schedule. Introduction of Multiple Choice Questions and Online pattern partially in internal examinations.
- d) For semesters V & IV, Theory examination will be conducted for 75 marks, minimum pass marks for External Examination is 35% candidate should get a total of 40 marks in internal and external examination put together.
- e) For semesters III, IV, V & IV, Internal Assessment will be conducted for 15 marks. Average of two examinations conducted, should be taken into consideration.5 marks were allotted for Assignment/Viva, and another 5 marks for students attendance. No minimum pass mark for internal assessment.
- f) Practical Examination will be conducted at the end of each Semester for 50 marks.

**Resolution 3:** Resolved to approve the model question papers of I, II, III, IV, V & VI semesters and Practical examination of I B.Sc., II B.Sc., III B.Sc., Zoology as appended.

**Resolution 4:** Resolved to approve the list of paper setters and examiners for all the semesters for I, II, & III B.Sc., Zoology for the year 2020-21 as appended herewith.
